



## RHCE 10th Anniversary Celebrations (1999 - 2009)



Dear Student,

Celebrating the 10th Anniversary of RHCE, beginning **May 01, 2009**, you can appear for the 2nd attempt on RHCE examination at just **Rs. 500\*** only.

### \*Terms and conditions

- This scheme is applicable only for those candidates who have undergone the official Red Hat training program on RHEL 5 leading to RHCE examination.
- This scheme is applicable only for those candidates who are registering for RHCE examination between **May 1, 2009** and **July 31, 2009** only.
- The fee for 1<sup>st</sup> attempt during the scheme period is **Rs. 12500** only
- The fee for 2<sup>nd</sup> attempt during the scheme period is **Rs. 500** only
- The last date for registration for the scheme is **July 31, 2009**
- **By registering and appearing for the examination before May 31, 2009, the candidate can avail additional benefits**
  - a) Training on RH184 – Red Hat Enterprise Virtualization program at just Rs. 1500
  - b) 25% discount on EX333 – Red Hat Enterprise Security: Network Services examination
  - c) The last date to register for training on RH184 under the scheme is Jun 30, 2009
  - d) The last date to register for EX333 examination under the scheme is Oct 30, 2009
- The last date for 1<sup>st</sup> attempt on RHCE exam under the scheme is **Aug 31, 2009**
- The last date for 2<sup>nd</sup> attempt on RHCE exam under the scheme is **Oct 14, 2009**
- Once registered, rescheduling/ cancellation of examination is not allowed
- Students, who do not appear for the examination after registration before the above mentioned dates, would be considered ‘no show’ and would forfeit the examination fee paid.
- The examination fee is non-refundable and non-transferable



- The following documents are mandatory to register for the RHCE examination
  - a) Red Hat Course completion certificate of RH033/ feedback form of RH033 in originals
  - b) RHCT Examination Registration form (attached along with RH133 kit)
  - c) RHCT Examination Discount Voucher (attached along with RH133 kit)
  - d) RHCE Examination Registration form (attached along with RH253 kit)
  - e) RHCE Examination Discount Voucher (attached along with RH253 kit)
  - f) Govt. issued ID proof such as Driving License/ voter's ID card/ passport/ PAN card/ etc.,
  - g) RHCE Examination coupons
  - h) 3 passport size photographs
  
- All the forms should be completely furnished by the student and signed by the concerned center manager/ director and sealed by the training institute where the participant has undergone training. It is mandatory to submit the above mentioned forms and the govt. issued ID proof to the examiner on the day of the examination. Without the forms, the candidate would have to pay Rs. 20,000 towards RHCE examination respectively.
  
- ***If the candidate has availed the discount, but fails to produce the registration form and discount voucher on the day of examination, he would have to pay the difference immediately by DD in favour of Red Hat India Pvt. Ltd.,” or forfeit the opportunity to attend the examination and the fees paid towards the same.***
